1. PAYG tax is NOT deducted from MTS Scholarship Payments at time of payment. MTS Scholarship Payments are *non-taxable income* if apprentice is enrolled theological studies in a full time capacity.

MTS Scholarship Payments need to be declared as *Taxable Income* in an individuals annual tax return for any period that the apprentice is NOT enrolled in theological studies in a full-time capacity.

- 2. Stipends calculated as National Minimum Wage (\$915.90 per week) pro-rata for the number of days per week ministry experience.
- 3. MTS Scholarship Apprentices are not guaranteeed to receive Austudy / Youth Allowance.

Austudy / Youth Allowance is subject to individual eligibility and Income/Asset tests and minimum study load of 75% of full time (ie 3 subjects per semester).

Examples shown are the MAXIMUM level of AUSTUDY for single student, no children.

If personally eligible, MTS Scholarship Apprentices studying the ASTC will only be able to receive Austudy for 1 semester per year.

Austudy is only available for first year studies (Cert IV Christian Ministry and Theology) undertaken with MTS Blue Collar Scholarship (VBC)

- 4. Scholarship Values may be adjusted depending on Apprentice eligibility for Austudy / Youth Allowance
- 5. Eligible Diploma course fees may be charged to FEE HELP. FEE HELP cap of \$102,000 per student applies for any studies in higher education sector.
- 6. A refundable MTS Training Bond of \$3000 per apprentice is required to be deposited with MTS for each MTS Scholarship Apprentice.

The MTS Training Bond is refundable at the completion of an Apprentice Scholarship - subject to the Scholarship being fully funded.

7. Vocational Bible College course fees are \$4000 for 1st year (Cert IV Christian Ministry and Theology) and \$5,200 for 2nd year (Diploma Christian Ministry and Theology). Course fees indicated are the average per ann over Yr 1 and Yr 2.
